The Skagit Board of County Commissioners (BCC) will hold a public hearing to take testimony on whether to docket Anacortes' petition of annexing 11.15 acres of County land to Anacortes' urban growth area (UGA). The acreage is needed for Tethys' proposed bottling plant operation. Each person will be allowed three minutes to testify. The BCC is treating the petition as non-project; thus your testimony should be generic when addressing if light manufacturing or what size of such should be located on this acreage. The BCC has chosen not to address Tethys' bottling plant impacts on the environment nor the community.

TURNER BAY POCKET SALMON ESTUARY WETLAND AND STREAM BUFFERS

According to Betsy D. Stevenson, Skagit County Planning & Development Services,

A map review indicates that a majority of the site [estuary] is either wetland or hydric soils. A wetland delineation and assessment would need to be completed in order to determine wetland buffers. The buffers would be based on the category of the wetland and the intensity of the proposed use.

In addition, there is a fish stream that runs through the site. The stream buffer would be 100 feet if the stream were less than 5 feet wide or 150 feet if the stream were greater than 5 feet wide.

The shoreline area is designated as Rural. There has been some recent restoration work (see SRSC Turners Bay map at http://www.skagitcoop.org/index.php/turners-bay-pocket-estuary-restoration/), which removed a portion of the road to restore tidal influence and provide enhanced fish access. Additional site work (extent of salinity) would need to be done in order to determine the extent of shoreline jurisdiction, along with the determination of possible associated wetlands from the wetlands delineation and assessment.

As far as which buffer would apply, County requirements apply to the unincorporated portion of the UGA. If an annexation were approved, then the City of Anacortes' regulations would apply [to the estuary]. SEE MAPS ON THE NEXT PAGE.
